This can be downloaded from the Windows 7 Support Site, but I would strongly recommend you download the DVD instead. After installing the Windows 7 SP2 boot CD, follow the instructions to create a bootable Windows 7 CD. Then, you will have to disable Fast Boot and shutdown the computer. When you start the computer, you will be presented with a message stating that the Windows 7 SP2 boot CD is not detected. You will then need to press ENTER to continue. After pressing ENTER, the computer will be rebooted and a Windows 7 bootable CD will be mounted on the startup drive. You can then perform a repair installation of Windows 7.
